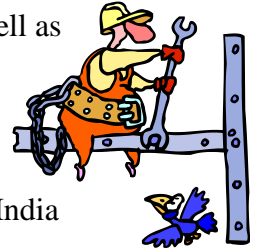

## NEWS FROM THE VICE PRESIDENT FOR PUBLIC POLICY

The Food and Drug Administration has let companies certify the safety of the chemicals that are being used in their products. So many additives are being added that the FDA doesn't know about. They have received many complaints about some additives triggering asthmatic attacks, serious vomiting and intestinal disorders and other health problems in some people. It is important for consumers to check all ingredients and report any untoward effects but there are secret ingredients that aren't always listed on the product can or box.

The FDA officials have acknowledged that new steps need to be taken to better account for additives being added to food. The number of additives has spiked from 800 to more than 9,000 in the last 50 years.

With elections coming this fall, it is important for voters to scan the position that the candidates take on issues that are important to you and the country. Too many people don't follow the information put out by the candidates so they are disappointed that they don't support the issues important to us.

### BYLAW CHANGE

The current bylaw reads:

#### ARTICLE V. Officers

##### Section 1. Officers

B. Officers, with the exception of President Elect, shall serve for a term of two years. Newly elected officers shall take office on January 1, following the conference at which they were elected. **No officer shall serve more than one consecutive term in the same office, with the exception of the Treasurer who may serve consecutive terms.**

The proposed change is in the second sentence would read:

**All officers may serve consecutive terms in the same office.**

## Do Not Delay – Pay Today!

In September we return to scheduled activities and it is time for us to pay our FCE dues for 2015. All dues must be paid to club treasurers in September and forwarded to the county treasurers by October.

Every member is required to fill out a 2015 Membership Form. The 2015 membership form is printed in this newsletter. Please tear it out and using black ink type or clearly print the information requested at the top of the page. Do not use abbreviations. Enter your 9 digit zip code and your E-mail address. Your “Current Member I.D. #” is printed on your FCE Membership Card.

Please note that in the dues box there is a new category – Youth. The Youth category is for someone who is 18 or under whose parent is not a member and the young person wants to be a member of FCE.

In the dues box circle your membership status: regular, family, senior, or youth. Fill in the appropriate dues for county and clubs as they vary throughout the state. Total the column.

The last item – the Member Signature at the bottom of the page must be the signature of the individual named at the top of the page.

### New Members

Note the box above the Member Signature line. This should be checked by individuals who have never been affiliated with FCE. At the bottom of the page add “recruited by” and give the name and address of the member who introduced the new member to FCE. The member will receive a gold star pin from National FCE.

**SPECIAL PRIZE** – Each new member and the recruiter’s name will be placed in a drawing for full registration payment for the 2015 Maryland Annual Conference Meeting. The more members you recruit – the more chances you will have to go to the meeting for free!

**National FCE President Bonnie Teeples  
July 18, 2014**

***Annual Conference Tucson, Arizona***

I am a different person than the one that stood before you a year ago. I have had experiences this past year that have shaped me, I hope refined me, and they have certainly made me more aware of the workings of human nature, my own included. I have served with a diverse group on the National Board. There are the detail people, the dreamers, the deep thinkers, the analyzers, some “newbies” and some old hands. But all of them have one **DREAM** as board members and that is to improve the quality of the organization.

The board has worked hard this past couple of years to make and keep earlier deadlines. Decisions are made on the programs that will be presented at conference the following year and by fall board meeting much of the research is done. By the end of fall board meeting it is hoped that the teams have a working outline and the basics of what they will do in the workshop. This has helped to make the work of all committees go much smoother. The recommendation was passed without debate. Part of the refining I have gone through was a result of the experience I had in India. You cannot visit places like that, meet wonderful people like that, and not be changed. It truly was a life changing experience for me.

FCE history was made when we formally recognized a Youth Membership Category and with the election of the first male to the National

Board. Both bring welcome diversity and a new way of looking at things to the organization and certainly to the board.

Our membership numbers continue to drop and with it the income available for program development, purchase of needed materials, and membership support. Recruiting and retaining new members continues to be of primary concern to the National Board. Judy Jones, administrative assistant at headquarters, continues to offer money saving ideas to the board. We are grateful to her and so appreciate the work she does for us as well as the organization.

I am ecstatic that we have so many candidates running for office this year. It shows that you all have the good of the organization at heart and have ideas you want to implement that you hope will make things continue to grow and improve.

As a board we have begun to look at current programs with an eye to their usefulness to our mission, vision and goals. We know change is hard for any organization, but we also know that to survive we need to move forward and sometimes change is a part of that.

Our theme for conference this year was “**Team Work Makes Dreams Work**”. I hope you have a dream and I hope that what we are doing as a National organization is helping you to make your dream work. **We want you to be a part of making our dream work.**
