PUBLIC POLICY NOTES Cannabis / Pot / Marijuana

During the war on drugs, marijuana went under ground 25 years ago. Skilled Mom-and-Pop growers have been developing many high preforming cultured varieties using new techniques and technologies during the interval. Marijuana has never been more potent, more productive and more varied. As the supply has increased, the price has dropped. What cost \$5,000 a pound 15 years ago now sells for \$3,000 today. By 2002 as much as 10,000 metric tons were cultivated annually in the United States - valued at more than \$35 billion while the corn harvest was \$23 billion.

Fourteen years ago Californians approved medical marijuana and now they are considering "Proposition 19" which would allow people 21 or older to cultivate, possess and use small quantities of marijuana and let local governments' license commercial growers and retailers. In the past 10 years, Mexican drug organizations have increased their outdoor growing operation in the United States from the West coast to states such as Arkansas, Georgia and even Wisconsin. Many hobby growers use indoor gardens with the use of LED lighting to keep electricity bills lower so as not to alert authorities. Washington, DC, as well as 13 other states are on their way to allowing the chronically sick to obtain marijuana even though there is a federal law against it. Those who advocate the DC law feel that it is so restrictive as to be impractical. It doesn't allow home cultivation and permits just 5 to 8 growing centers and dispensaries, limited to 95 plants each.

Federal sentencing mandates require 5 year prison terms for possession of 100 or more plants. Maryland judges can lower the fines for medical marijuana cases but one can still be arrested and convicted. Virginia has no medical marijuana law.

The potent part of marijuana giving the "high" is THC but the other aromatic essential oils affect the nature of the intoxication and the medical effects. Experts say the high potency has transformed marijuana into a drug that can cause psychosis and paranoia and increase addiction. Today the emergency centers are seeing an increase in admissions.

ACWW News A STRONGER VOICE SPEAKS FOR WOMEN

A drive to advance the rights of women reached a new stage last summer when the United Nations General Assembly voted unanimously to create a dynamic new organization by merging four UN Offices focusing on gender equality.

"The newest member of the UN family has been born", Secretary-General Ban Ki-moon declared to the assembly after it had agreed to set up an agency to be known as UN Women. "This is truly a watershed."

Four former agencies have merged: the UN Development Fund for Women (UNIFEM), the Division for the Advancement of Women (DAW), the Office of the Special Advisor on Gender Issues, and the UN International Research and Training Institute for the Advancement of Women (UN-INSTRAW).

The Secretary-General said: "By bringing together four parts of the UN system dedicated to women's issues, member states have created a much stronger voice for women and for gender equality at the global level. "It will now be much more difficult for the world to ignore the challenges facing women and girls-or to fail to take the necessary action."

UN Women is the result of years of negotiation among member states and calls for action by the women's movement. It will become operational in January and power the UN's work to promote women's rights.

It will have an annual budget of US \$500 million-double the combined resources of the four previous agencies.

Ban Ki-moon acknowledged that many countries face spending constraints because of the global economic downturn but expressed confidence that the new office will receive strong financial support.

"UN Women is recognition of a simple truth", he later said in a statement. "Equality for women and girls is not only a basic human right; it is a social and economic imperative. Where women are educated and empowered, economies are more productive and strong. Where women are fully represented, societies are more peaceful and stable."

One of the main goals of UN Women will be to support the Commission on the Status of Women and other inter-government bodies in devising policies. It will also help states to implement standards, provide technical and financial support to countries which request it and forge partnerships with civil society.

Within the UN, it will hold the world body accountable for its own commitments on gender equality.

Protect Yourself Against the Dangers of Cosmetics

• Never drive and put on make-up. Not only does this make driving a danger, hitting a bump in the road and scratching your eyeball can cause serious eye injury.



• Never share make-up. Always

use a new sponge when trying products at a store. Insist that salespersons clean container openings with alcohol before applying to your skin.

- Keep make-up containers closed tight.
- Keep make-up out of the sun and heat. Light and heat can kill the preservatives that help to fight bacteria. Don't keep cosmetics in a hot car for a long time.

• Don't use cosmetics if you have an eye infection, such as pinkeye. Throw away any make-up you were using when you found the problem.

• Never add liquid to a product unless the label tells you to do so.

• Throw away any make-up if the color changes or it starts to smell.

• Never use aerosol sprays near heat or while smoking, because they can catch on fire.

• Don't deeply inhale hairsprays or powders. This can cause lung damage.

• Avoid color additives that are not approved for use in the eye area, such as "permanent" eyelash tints and kohl (color additive that contains lead salts and is still used in eye cosmetics in other countries). Be sure to keep kohl away from children. It may cause lead poisoning.

Closing the Prescription Drug Coverage Gap

You Could Be Eligible For A \$250 Rebate This Year to Help with your Medicare Drug Costs



What's Next...Coming in 2011. If you reach the coverage gap in 2011, you will get a 50% discount on your brand

name prescription drugs at the time you buy them, unless you are already getting Medicare Extra Help.

Help us spread the word about this important benefit and help stop scams against seniors. Pass this information along to your friends, neighbors and family so they know the facts about this important program. Remember—there are no forms to fill out to receive this benefit once you qualify for it. Medicare will automatically send a check that's made out to you. You **don't** need to provide any personal information like your Medicare, Social Security, or bank account numbers to get the rebate check.

Don't give your personal information to anyone who calls you about the \$250 rebate check. Call 1-800-MEDICARE (1-800-633-4227) to report anyone who does this. TTY users should call 1-877-486-2048.

Go to **stopmedicarefraud.gov** to learn more about how Medicare is working with law enforcement to stop scams against seniors.

Have other questions about the \$250 rebate check or the Affordable Care Act and Medicare? You can also visit www.medicare.gov or call 1-800-MEDICARE.

The Affordable Care Act passed by Congress and signed by President Obama this year contains some important benefits for Medicare recipients. If you have Medicare prescription drug coverage, and aren't already getting Medicare Extra Help, Medicare will automatically send you a tax free, one-time \$250 rebate check after you reach the coverage gap (also called the "donut hole") in 2010. This rebate is the first step toward closing the Medicare prescription drug coverage gap.

What is the coverage gap and how will I know if I've reached it? Most Medicare drug plans have a coverage gap. This means that after you and your plan have spent a certain amount of money for covered drugs, you have to pay all costs out-ofpocket for your drugs (up to a limit). The Explanation of Benefits notice, which your drug plan mails to you each month when you fill a prescription, will tell you how much you've spent on covered drugs and whether you've entered the coverage gap.

Will I need to do anything to get this rebate check? No. There are no forms to fill out. Medicare will automatically send a check that's made out to you. You **don't** need to provide any personal information like your Medicare, Social Security, or bank account numbers to get the rebate check.

Don't give your personal information to anyone who calls you about the \$250 rebate check. Call 1-800-MEDICARE (1-800-633-4227) to report anyone who does this. TTY users should call 1-877-486-2048.

When will I get the rebate check? If you reach the coverage gap this year and enter the Part D "donut hole", you will receive a one-time \$250 rebate check if you are not already receiving Medicare Extra Help. These checks will begin to get mailed to beneficiaries starting in mid-June. Checks will be mailed monthly throughout the year as beneficiaries enter the coverage gap. However, this is a one-time benefit and if you qualify, you will only receive one check after you reach the coverage gap.

Will I have to pay taxes on rebate check? No. You don't have to pay taxes on your \$250 rebate check. It is tax free.

What if I don't get the rebate check when **I should?** If you hit the donut hole after the program has begun, you should expect to receive your check within 45 days. Your rebate may be delayed if Medicare doesn't have information from your Medicare drug plan showing that you reached the coverage gap in time to include you in the next mailing. You should call your Medicare drug plan to make sure all of your information has been sent to Medicare. If you don't get your rebate check, contact Medicare at 1-800-MEDICARE. Individuals receiving Medicare Extra Help will not receive a rebate check. You can also check to make sure Social Security has your correct home address. Call 1-800-772-1213 or your local Social Security office. TTY users should call 1-800-325-0778. (Source Centers for Medicare & Medicaid Services CMS Product No. 11464 May 2010)

Baked Apples with Sweet Potatoes

5 sweet potatoes 4 apples 1/2 cup brown sugar 1/2 teaspoon salt 1/4 cup margarine 1 teaspoon nutmeg 1/4 cup hot water 2 tablespoons honey

1. Boil sweet potatoes in 2 inches of water until almost tender. Cool potatoes, peel and slice.

2. Peel, core, and slice the apples.

3. Preheat the oven to 400°F. Grease the casserole dish with margarine.

4. Put a layer of sweet potatoes on the bottom of the dish.

5. Add a layer of apple slices.

6. Add some sugar, salt, and tiny pieces of margarine to the apple layer.

7. Repeat steps 4, 5, and 6 to make more layers.

8. On the top layer of apples, sprinkle the rest of the brown sugar, margarine pieces, and nutmeg.
9. Mix the hot water and honey together. Pour the mix over the top layer.
10. Bake for about 30 minutes, until apples are tender.

Makes 6 servings.
