It is with a heavy heart that we send condolences to the family of our oldest member, Martha Breslin (Montgomery County) 100 years young, passed in April. She was also the past-president of Prince George's County FCE. She will be truly missed.

PUBLIC POLICY NOTES

Some of the many bills that were proposed and/or passed include:

1. The bill to punish adults who provided alcohol to people younger than 21 was weakened because they felt that it might mean jail time for college students who provide beer to friends who are underage. The bill that passed would impose jail time and higher fines only if the adult knew or should have known that an underage drinker would drive and cause serious injury or death to another individual.
2. Justice Reinvestment Act requires inmates who are ordered to pay restitution to set aside 25% of their inmate earnings for those payments. The bill aims to reduce Maryland's state prison population and costs by shifting nonviolent drug offenders into treatment and includes provisions for restitution and funding for victims' rights programs.
3. One bill to require those convicted of domestic violence offenses to turn over their guns was passed. No other progress was made to add additional gun restrictions.
4. A bill was passed that not all 5 year-olds would have to take a readiness test for kindergarten.
5. A bill passed to make it harder for companies to buy annual settlement payouts for small lump sums. This was due to the lack of paying as committed to lower economic persons.
6. A bill to change the Maryland state song because of words in it praising the Confederacy did not advance.
7. A bill was approved to expand the use of ignition locks for drunk drivers. The bill lowers the blood alcohol level at which locks are required to 0.08. Also anyone who has failed a breath-alcohol test will be required to have locks installed. This is called Noah's law.

Bees, Our Tiny Friends

We have been hearing about the reduction in numbers of the bee population for the past few years. Many people see bees as pests and grab the insecticide for fear of getting stung, but bees are very vital to our food chain. Master Gardener, John Connors, gave a presentation full of amazing details about bees at our county meeting. There has been a sharp decline in bees in recent years which is of concern not only to farmers, but should also be of concern to consumers. It was stated that one of every three bites of the food we eat is pollinated by bees.

One hive can have 50,000 bees which sounds like an incredible number until we learn that it takes pollen from 2 million flowers to make one pound of honey and that a single bee produces only one twelfth of a teaspoon of honey in his lifetime.

Products pollinated by bees support billion dollar industries. Bees pollinate grapes (wine industry), alfalfa (dairy cows), apples, almonds, berries, canola, soy, cotton, and more, all products we depend on but take for granted the important role of the lowly busy little bee.

Cell phones have been blamed for the severe drop in the bee numbers, but those studying the problem believe it may be caused by a parasite, varroa mite, insecticides, poor diet, or would you believe "stress." Maybe equipping the hives with some soothing music might help relieve the stress!

The Triennial Conference is the most important event in the ACWW calendar, and offers members the opportunity to elect their representatives, vote on resolutions and help guide the next three years of ACWW's work.

What is Human Trafficking?

The FBI says human trafficking cases in the United States tend to fall into four different areas:

- Domestic sex trafficking of adults – This involves adults who are compelled to engage in commercial sex acts, generally through force, fraud or coercion.
- Sex trafficking of international adults and children – This involves foreign nationals who are brought into the country for the purpose of engaging in commercial sex acts.
- Forced labor – This type of trafficking involves American citizens or foreign nationals who are made to perform work through force or coercion.
- Domestic servitude – Trafficking of this type involves forcing or coercing citizens or foreign nationals to perform domestic work for households/families.

How Big is the Problem?

The question isn't as easy to answer as it might sound, law enforcement officials say. The [Florida Coalition Against Human Trafficking](#) estimates there are 20.9 million people “enslaved throughout the world.” The [National Human Trafficking Resource Center](#) estimates it's received 25,791 case reports since 2007. But, trying to pinpoint a set number of victims within America or even Florida or Tampa Bay just isn't simple, authorities say. “We don't know,” said Florida Department of Law Enforcement Special Agent Jose A. Ramirez.

The human trafficking resource center, which serves as a clearinghouse for tips, has fielded 7,272 calls from Florida since 2007, resulting in 1,907 cases. Most cases of human trafficking are developed through informants or citizen tips. Law enforcement would rather investigate a tip and find out that it's not human trafficking than not receive a tip that may have helped them recover a victim or victims.

When and Where to Report Suspicions

Anytime someone sees something that just doesn't look or feel right, it might be worth calling in a tip. In some cases, human trafficking victims can be very hard to identify – especially since many don't see themselves as victims. Authorities should be notified any time a citizen sees something that concerns them. Human trafficking related tips can be called into local law enforcement agencies directly. The National Human Trafficking Resource Center also has a 24-hour-a-day hotline available at 1-888-373-7888.
